Prevent Duty Risk Assessment September 2024



Introduction

Everyone who comes into contact with children and their families has a role to play in safeguarding children. Schools have a duty of care to their pupils and staff which includes safeguarding them from the risk of being drawn into terrorism - this includes not just violent extremism but also non-violent extremism, which can create an atmosphere conducive to terrorism and can popularise views which terrorists exploit. Schools should be safe spaces in which children and young people can understand and discuss sensitive topics, including terrorism and the extremist ideas that are part of the terrorist ideology and learn how to challenge these ideas.

School staff are particularly important as they are in a position to identify concerns early and provide help for children, to prevent concerns from escalating. Schools and colleges and their staff form part of the wider safeguarding system for children. This system is described in statutory guidance Working Together to Safeguard Children (2023) and Keeping Children Safe in Education (2024). Schools and colleges should work with social care, the police, health services and other services to promote the welfare of children and protect them from harm. Radicalisation is listed as a specific safeguarding issue within this statutory guidance and is addressed within the Government Prevent Strategy. The Counter-Terrorism and Security Act 2015 places a duty on Schools to 'have "due regard to the need to prevent people from being drawn into terrorism"'.

The Prevent Strategy has three main objectives:

- Respond to the ideological challenge of terrorism & the threat we face from those who promote it;
- Prevent people from being drawn into terrorism and ensure that they are given appropriate advice and support;
- Work with sectors and institutions where there are risks of radicalisation which we need to address.

Prevent Risk Assessment

Our Schools recognise that it has a duty under Section 26 of the Counter-Terrorism and Security Act, 2015, in the exercise of its functions, to have due regard to the need to prevent people from being drawn into terrorism.

There are threats that can be classed as local and national. These are:

Local threats

- The conflict in Palestine has led to increased peaceful protest action in the local area. Whilst this is not directly a Prevent issue, there is scope for young people and their families to be drawn into false and mis-information campaigns.
- Approx 29% of Bradford's population are under 18 years old. Anything that affects young people, affects Bradford disproportionately. This is particularly concerning in the online space.
- Bradford is a Prevent priority area, which borders three other priority areas. There have been multiple arrests of note in West Yorkshire, including of parents of Bradford children.
- The greatest number of referrals in the area are linked to the Extreme Right-Wing (EXRW).

National threats

- The rate of individuals convicted of a relevant offence, where there had been some element of online radicalisation has risen from 8% (pre 2007) to 92% (2021).
- There has been an observable rise in AI generated content on social media, particularly in line with recent elections. There has also been notable mis/dis-information relating to politics and media stories.
- Daesh Inspired/ Islamist extremism makes up approx. 75% of the MI-5 caseload. This continues to be well organised, planned and funded. This affords them greater opportunities to create mass casualty incidents, as opposed to other types of extremism.
- The Home Office are conducting a rapid review of Extremism and have suggested that misogyny will soon be added as an ideology. This will have an impact on the way these cases are viewed by Prevent.
